1. For Bidders other than certified Bonafide Himachalis

- (i) For 1 (one) ecotourism site, the Bidder shall have to show a positive Net Worth of Rs. 3,00,00,000/- (Rupees Four Crores Only) or above;
- (ii) For 2 (two) ecotourism sites, the Bidder shall have to show a positive Net Worth of Rs. 6,00,00,000/- (Rupees Eight Crores Only) or above.
- (iii) For 3 (three) ecotourism sites, the Bidder shall have to show a positive Net Worth of Rs. 9,00,00,000/- (Rupees Twelve Crores Only) or above;
- (iv) And so on and so forth

2. For certified Bonafide Himachali Bidders

- (i) **For 1 (one) ecotourism site, the certified Bonafide Himachali Bidder shall have to show a positive Net Worth of Rs. 1,00,00,000/- (Rupees Three Crores Only) or above;**
- (ii) **For 2 (two) ecotourism sites, the certified Bonafide Himachali Bidder shall have to show a positive Net Worth of Rs. 2,00,00,000/- (Rupees Six Crores Only) or above;**
- (iii) **For 3 (three) ecotourism sites, the certified Bonafide Himachali Bidder shall have to show a positive Net Worth of Rs. 3,00,00,000/- (Rupees Nine Crores Only) or above;**

3. For certified Bonafide Himachali Bidders

- (i) **For 1 (one) ecotourism site, the certified Bonafide Himachali Bidder shall have to show a positive Net Worth of Rs. 1,00,00,000/- (Rupees One Crores Only) or above;**
- (ii) **For 2 (two) ecotourism sites, the certified Bonafide Himachali Bidder shall have to show a positive Net Worth of Rs. 2,00,00,000/- (Rupees Two Crores Only) or above;**
- (iii) **For 3 (three) ecotourism sites, the certified Bonafide Himachali Bidder shall have to show a positive Net Worth of Rs. 3,00,00,000/- (Rupees Three Crores Only) or above;**
